- 2. Brian moved and Steve second To recommend the band chair that new NBD applications go in the reserved 100 k blocks. (MSP) 14 for, 0 against, 1 abstaining.
- 3. John moved and Brian Second that we Allow The bottom 100 khz in 146-147 from the traditional simplex region and divide it into 8 12.5 khz channels and 2 additional 6.25Khz channels at the ends for NBD in the 2 meter band (MSP) 10 for, 2 against.
