Review Proposed Changes to Coordination Polices

- NM7R provided summary of changes and had Q&A

- Discussed process to approve, all agreed there wasn't a need to postpone until next regular meeting.
 - o Motion made and seconded to approve. Vote was unanimous to accept
- o KU7M will produce a clean copy (minus change-bars) and post on website.

Band Plan Discussion

- NM7R / KU7M Provided overview of current issue under review by board around coordinating narrowband FM analog repeater on 146.425 pair. Which is one of special eight narrowband pairs created in 2010. Original proposal called out these pairs were for "exclusively for Narrow Band Digital repeaters".
- o Active discussion about policies intent and how poorly documented.

- N7SS agreed to draft a new proposal for review at March 3rd general meeting which addresses the poor documentation (using official FCC terms) and which allows new narrowband modes.
- o Final comment was overall need for WWARA to begin process of moving to narrowband channels, which will also require transition to narrowband analog FM, which is in alignment with FCC policy. The obvious benefit is the creation of additional 2m pairs, which are highly sought after and all current equipment can support. Transition will need to take into account those existing repeaters that don't support narrowband FM modes. Board agreed to draft a proposal for transition and necessary steps for member review in future.
